- I worked for Laming as a part time staffer for approx. 3 months in late 2018, following my resignation from Straddie Ferries and prior to my appointment as Growcom CEO
- Mr Laming made contact with me early in my Growcom tenure and asked if I could facilitate introductions to horticulture growers, who could be interested in a parcel of Commonwealth land at Birkdale
- I suggested that meeting them all in one place at HortConnect would make sense, rather than driving all over the state
- I told him that the annual Hort Conference, HortConnect was in Melbourne in June 2019
- I attended HortConnect with a delegation from Queensland and Mr Laming arrived at the gala dinner towards the end of the conference.
- Mr Laming was not a delegate to the conference but took the opportunity to attend as a visitor
- I introduced him to a couple of my table guests at the dinner and he then independently worked the room.

Summary: The Hobart segment is corroborated by both 475. The additional grounds for travelling twice out of Hobart align with electorate activity, verified by material outside the data loss window. The Melbourne segment is corroborated by 475. (above), which given the short travel window, also confirms the dominant purpose of the journey.

Should any element of this claim, upon investigation, be found to be a non-claimable expense (two taxi fares have already been identified), then prompt repayment is our intention.

Our responses provide all available recollection and evidence for each leg of these journeys. Our responses also demonstrate a clear intention to achieve the best possible value for money for the Commonwealth. For this reason, our Assurance response below remains a comprehensive summary of electorate and parliamentary duties (Part A), dominant purpose (Part B) and ancillary detail (Part C).

PART A: Hobart - Electorate duties - matters of importance to constituents

Attendance at national and state health conferences is for both electorate and parliamentary purposes.

As a Parliamentarian and invited speaker, participation has multiple outcomes.

- Provision of health policy expertise at electorate level to full-time clinicians resulting in greater interest in regional service provision.
- Refinement of legislative and regulatory policy through feedback to the executive. Meetings provide a barometer on government performance from leading stakeholders allowing review and development work by committees through Ministerial referral (Chair education and training).

The combination of specialist qualifications (MBBS, FRANZCO, DRCOG, MPubPol, MPA) is unique, meaning that in health planning discussions, my contributions at these conferences are made as both a member of the government communicating its policy but also as a subject matter expert on issues of importance or interest to regional, island and Indigenous constituents.

Bowman includes southern Moreton Bay islands (SMBI), where access to health and medical services is precarious. Attendance at and engagement with both general and specialist medical colleges aimed to;

- promote the health needs of regional communities and develop efficient solutions,
- outline specifically the unique health needs of bay island communities, and
- cultivate within clinical groups an interest in servicing these communities, providing an electoral benefit.

In 2019, a strong focus in the electorate was enhancement of health and hospital infrastructure. Additional infrastructure reduces patient travel and increases opportunities for specialist service provision in underserved regions. At the time of the 2019 conference the electorate focus included;

Hobart-Parliamentary duties-Developing, reviewing and amending legislation

At the time of the 2019 RANZCO - ANZSOPS Conference, a range of legislative matters were in the public domain, in development or subject to review by the government and requiring amendment. Each of the following topics formed the basis of my presentation and questions I fielded following my presentation.

 Workforce: March 2019, COAG <u>announced</u> the development of a <u>National Medical</u> <u>Workforce Strategy</u>. The aim of the strategy was to guide long-term, collaborative medical workforce planning across Australia. Access and distribution of eye services to regional, rural and remote Australia was likely to be reliant on <u>A Stronger Rural Health Strategy</u> with the aim of providing 3,000 more doctors, into rural and regional areas over the next 10 years.

Medical Research Future Fund: There was a high level of interest in how this
additional allocation to research would be distributed, the balance between
benchtop and service delivery research and whether the allocation would be
politically influenced, together with duplication concerns around the NHMRC.

Hobart-Parliamentary duties- Research and communication connected with the business of the Parliament

Geographic classifications under our current health system have an impact on Medicare payments and on medical practice. The audience asked for specific details on whether this system would undermine the provision of services within the Bowman electorate or support existing services by offering locum and close clinical support. The application of RAMA arrangements and the Modified Monash remoteness scales impacted GP distribution and in turn, referrals from regional areas.

Training: The audience also focussed on the proposed <u>National Rural Generalist Pathway</u> (NRGP) and how specialist training could also increase regional intake to reduce geographic maldistribution but also asymmetries and underrepresentation in the trainee cohort.

Pharmaceutical benefits and services: comprised largely of Australian Government subsidies for anti-VEGF agents. Changes to these items which would affect not just practice viability but the ability of clinicians to perform marginally viable work in regional locations. Mechanisms to increase competition by bringing *Avastin* through the TGA as a more economical alternative was the key concern for delegates.

My Health Record: There were concerns about the PHR, Digital Health agency, data storage and challenges for medical specialists who were not running online patient management systems.

Private health care: Reforms to private health insurance

(https://www.health.gov.au/resources/publications/private-health-insurance-reforms-gold-silver-bronze-basic-product-tiers-campaign-fact-sheet) in 2019 aimed to increase choice and transparency and affordability in the sector in order to arrest a decline in levels of private health cover.

Maintaining the viability of the sector was a priority, particularly in Bowman where a single private hospital provider was hosting much of the region's specialist medical work. Closure would have significant impact on availability of obstetric, day surgery and procedural work. Speaking at the conference aimed to:

- raise confidence in the Government's measures,
- maintain, if not increase willingness to provide services in regional Australia (IDEAS van), and
- discuss mechanisms to provide services to regions where specialist services don't exist.

Conference feedback from clinicians and practice managers helped to better understand how constituents can minimise out-of-pocket costs and secure earlier appointments for surgery. This information is extremely difficult to obtain without directly engaging clinical practice managers.

Declining PHI levels have direct impact on the viability of these private health services and the propensity of specialist colleagues to continue servicing regional areas like the islands in the Bowman electorate.

As the deadline for formal abstracts was May 24, the published program for the conference had already been finalised prior to confirmation of my attendance June 11. For this reason alone, my name did not appear on the online version of the program document, despite there being a clear 45-minute break period where my presentation was ultimately delivered.

PART B: Tasmania road travel - Electorate duties - matters of importance to constituents

The electorate and Parliamentary grounds for travel to the RANZCO - ANZSOPS Conference travel are outlined above.

If there is any remaining doubt about the electorate and Parliamentary purpose of the Hobart conference in the Assurance process, specific questions can be answered in additional detail.

Part B now outlines additional electorate and Parliamentary-related activity in Hobart that confirms dominant purpose for the entire Hobart period. It also establishes that there was no significant activity in the three day period not related to parliamentary or electorate duties.

To maximise taxpayer value-for-money, two other opportunities were included during the three-day stay and arranged by me after the Hobart RANZCO - ANZSOPS Conference address was confirmed.

- 1. Seeing sites (not sightseeing) where composite fibre technology (CFT) construction products have been deployed in environmentally sensitive boardwalk proposals, and
- 2. Independent Schools Tasmania roundtable meeting with three experts (see part C).

1: Boardwalk construction in environmentally sensitive sites

The development of a *Redland City coastal foreshore boardwalk network* is an electorate proposal to design, approve and construct an active transport and tourism infrastructure network using materials suited to the sensitive intertidal ecosystems, that will survive the harsh marine, saline environment and Q100 weather events. The project was conceived, driven and now managed by the Bowman electorate office. The objective is to connect Brisbane Airport arrivals with the Moreton Bay coastline through to the Gold Coasts 'Ocean Way' providing an active transport tourism infrastructure piece that brings international visitors to the Moreton Bay Coast and is complete by the 2032 Olympic Games. This plan was;

- one of the two largest election commitment projects in 2019, just two months prior to travel
- In development since late 2018 (appendix)

The Tasmania visit was critical to this electorate project. There are is no better place in Australia to observe the construction design and impact of similar boardwalk structures than Tasmania.

Tasmania is a leader in the use of specialist composite fibre boardwalk structures for these harsh and ecologically sensitive environments and the RANZCO conference timetable offered brief opportunities to visit a number of sites.

The Tasmania visit has subsequently led to;

 a detailed boardwalk proposal for the Bowman electorate by engaging with one of Australia's two manufacturers of these products,

- Correspondence with relevant State Government ministers on these matters
- Collaboration with the LGA to fully fund the replacement of ageing boardwalk assets (https://news.redland.gld.gov.au/2021/07/stimulus-funding-spans-replacement-ofpedestrian-bridges/) with novel composite materials. (https://investment.infrastructure.gov.au/about/local-initiatives/local-roads-andcommunity-infrastructure/).





Meeting with Independent Schools Tasmania

The Monday meeting with IST establishes that work directly relating to my electorate and parliamentary duties occurred on all four days of the Tasmania journey.

Parts A and B outline the parliamentary and electorate purpose of the Hobart journey;

- Conference and associated event attendance over two days,
- Boardwalk project inspections on two journeys out of Hobart, and
- IST roundtable meeting.

Parts A and B outline that there was no significant part of the Hobart leg that was not electorate or parliamentary in nature.

If there is any remaining doubt about the dominant purpose of the Hobart leg in the Assurance process, specific questions can be answered in additional detail.

PART C: Other related matters

Q1: Launceston flights: The original intention was to complete visits to composite fibre technology boardwalk projects after the Hobart Conference and *en route* to Launceston. When this was no longer feasible and the additional Hobart meeting confirmed, flights were changed. It is routine practice to cancel a booking when re-routing occurs and I had no idea this did not happen when it was requested.

Q2: Hobart conference arrangements were confirmed in the days prior to the June11 accommodation booking.

Q3: This was a long-standing invitation from the organisers, and 2019 was the first time that I was available to attend.

Q4: Those details were previously provided to IPEA, when Dr Nitin Virma provided written confirmation of my presentation at the conference.

Q6: Details of <u>nightly accommodation</u> for Laming family members while travelling on 21-23 June.

Accommodation was at Amberley House in Sandy Bay; paid online June 12, 2019. All required documentation was provided at the time as prerequisite for reimbursement. Our data from that period has been lost from Outlook archive. The credit card evidence of purchase is below.

Due to a family member falling ill, a hotel room at the conference venue was also secured to make caring for children easier. This room was not submitted for reimbursement. The Tasmania leg was three days, and the three-day claim submitted concurs.

Vehicle travel:

Mileage for this journey was not at tax-payer expense. It has been usual practice whenever renting a vehicle for Parliamentary purposes to pay personally for fuel unless time prevents a final tank fill at the airport. My understanding is that the tank was completely filled at Hobart airport prior to departure to ensure that none of the mileage costs were at Commonwealth expense. This practice is long-standing does not imply the use of the vehicle is not Parliamentary.

This is and has been my usual practice since becoming an MP- to pay personally for fuel and not to use the fuel cards provided. This was the case in Hobart with the vehicle being re-filled at Hobart airport at my expense prior to departure.

Q7: Aside from use for airport returns on Friday and Monday, best recollection of travel as a family group was;

Saturday:

Conference/evening event for electorate and Parliamentary purpose Central plateau national parks. 600km route (Highland Lakes Rd) for electorate purpose

Sunday:

Conference for electorate and Parliamentary purpose Sorell / Port Arthur return. 200km (Arthur Highway) for electorate purpose

Monday:

Parliamentary meetings Sandy Bay for Standing committee and electorate purpose. Mt Wellington return

Specific **site seeing** (not sightseeing) was based on attempting to visit and inspect the significant use of composite fibre technology (CFT) boardwalk materials in particular Tasmanian locations. These materials were not widely used in my region of Queensland at the time.

Tasmania has a significant history deploying such materials in harsh environments and areas of high environmental sensitivity. These included Sorrell, Bicheno, Port Arthur, Great Lakes and the more easily accessible entries to national parks. These areas possess many similarities with the delicate RAMSAR protected intertidal grasses and mangroves which require minimally impacting construction techniques to deliver these projects.

Site meetings with relevant authorities was not possible on weekends, so I have made an offer to reimburse this vehicle car hire for the 24hour period. Since this is not possible, then the electorate justification for the travel stands. Meetings with authorities who were experts in these materials and projects were held at a later date, including three visits to the electorate, meetings with both Redland and Brisbane LGAs and a mapping project for electorate benefit that stems directly from this original journey.

This Tasmania visit formalised what became the **Bowman coastal foreshore boardwalk project**. The Tasmania visit was integral in activating this project for electorate benefit and securing the support of other levels of government, materials experts, environmental consultants, project designers and builders.

Q10: Outline how the meeting with Independent Schools Tasmania meets the definition of parliamentary (and/or electorate) business.

The electorate and Parliamentary grounds for travel to Hobart was the Ophthalmology conference. This IST meeting is relevant to assessment of dominant purpose.

While there are both Parliamentary and electorate benefits that accrue from meeting with school organisations at any time, my specific interest was to understand the approach of a unique jurisdiction to Commonwealth programs, given that Tasmania operates Senior Colleges, rather than y7-12 high schools. The meeting was based on my Parliamentary Standing Committee Chair role and the ministerially referred parliamentary inquiry I was chairing at the time.

The appointment was initiated in an effort to maximise taxpayer value for money for the journey and to seek specific feedback on the following programs IST have responsibility for. This research and consultation benefits my electorate (understanding threats and opportunities for Chaplaincy), my work as Education Standing Committee Chair, and the development and review of the function of legislation controlling each of the following (best example is the impact at the time of the CAF).

- The Choice and Affordability Fund (CAF)
- The Australian Government Capital Grants Program (CGP)
- The National School Chaplaincy program (NSCP)
- The Special Learning Needs program (SLN)
- Vulnerability and Early Childhood and Kindergarten funding (ECD)

MELBOURNE

PART A: Melbourne leg - Electorate duties - matters of interest and importance to constituents

Attendance at Hort Connections was the most important stakeholder meeting opportunity in the 2019 year. It directly related to a crucial electorate matter at the time and since; the divestment of Commonwealth land in Birkdale (Budget 2018), and efforts to land a legacy project for that site with Commonwealth support, to justify the price paid by ratepayers for the transfer of that asset between jurisdictions (Commonwealth to LGA). Announcement of the deal was just nine weeks prior to Hort Connections. (https://www.redlandcitybulletin.com.au/story/6041212/council-to-buy-birkdale-bush-block/)

Owing to a Monday evening Conference engagement in Canberra and a Tuesday electorate meeting, only Wednesday attendance was possible. The sole opportunity to network effectively across this Conference was the Awards evening when key grower groups could be identified and engaged via the seating plan for the event.

A Queensland AusVeg representative provided informal advice on when, where and who to meet. This was not a formal invitation from that organisation, because I was attending at their suggestion, rather than on their behalf. As a conference I had attended previously, I had sufficient awareness of Conference proceedings to attend at the appropriate time in the evening and to independently seek out those relevant to the revised Food Hub electorate proposal.

Electorate grounds for travel include but are not limited to:

- a) Attracting a university to the electorate. The Food hub proposal had been developed in 2018 but required redesign when a university funding application to relocate to the site was unsuccessful in April 2019. The initial plan for a food science hub and learning centre for post-graduate students was expanded at that point to demonstration farming, agri-tourism and a paddock to plate offering that captured the indigenous, heritage and agricultural value of the site.
 - Hort Connections was an irreplaceable opportunity to approach interstate Agriculture faculties like UNE but this correspondence on commercial matters is sensitive. Interstate tertiary providers enjoyed greater strategic benefit in re-locating than Brisbane providers who would effectively be duplicating their assets. For that reason, attending the national event was critical.
- b) Continuing the grower presence in an urbanising electorate: Also important was to discuss soil testing to allow better targeting of potential demonstration farming crops, in order to entice grower relocation. Meetings were held with tomato, brocollini, bean and mango growers. Strawberries are already grown locally, and relocation options had already been explored within Queensland. Hort Connections 2019 was an opportunity to meet grower groups and their representatives. The focus was interstate rather than Queensland grower groups because the former also saw strategic benefits in relocation to south-east Queensland, in contrast to many domestically based growers.
- c) Supporting Pacifica produce in my electorate: There was also work to assess suitability for tropical root and tuber harvesting. This is one of the largest local products grown in Bowman, due to the sizable Pacifica population in south-east Queensland. Expertise in this area was not high at local campuses. Part of the electorate duty had been to identify and

negotiate suitable plots for Pacifica farmers like 34.45 to continue his cropping on behalf of his community. contact details are available. Food hub work would directly benefit this cohort of my electorate (even though not all of them are enrolled to vote).

d) Broadening the tourism offering diversifies local job opportunities: Paddock to plate concepts are also more frequent in southern states. There had been contact with a number of them, with many suggesting attendance at Hort Connections. Blending agriculture with retail hospitality is complex and attending Hort Connections was an attempt to secure the best minds to help finesse the proposal.

Most important of all were attempts to connect with every relevant interstate grower group to assist with revision of the electorate Food Hub proposal, which at the time had lost its university faculty centrepiece (UNE). As a result, a pivot towards a paddock to plate offering and demonstration small-scale cropping was required in that instance. Those individual exchanges and email follow-ups are unavailable from the Outlook archive.

Melbourne: Business arising from other formal non-Parliamentary groups

Redland Foodies

In October 2018, Redland Foodies was initiated in the Bowman electorate office, to build support for the Food Hub. This group had its own private Facebook page, and had its first in-person meeting October 29 that year. This non-Parliamentary group was assisting to re-design the Food Hub proposal, after failure to fund the relocation of a university faculty to the site just two months earlier.








The objective of attending Horticulture Connections was to capitalise politically on the Commonwealth divestment of a Birkdale ACMA site to Council, on behalf of the electorate. The plan was to use proceeds of the divestment to seed fund the hub. The following documents are available as they are from prior to the January 2019 data loss window.

Redland Institute

The Redland Institute is a second formal non-Parliamentary group which I represented in Melbourne. I had taken over the public meeting and social media function of this entity in the

previous year when one of the founders passed away. Proposals for utilisation of the Commonwealth land were discussed publicly at Redland Institute events which were open discussion forums at Cleveland Guides Hall. Events were promoted by bulk email and sms, and the media and all levels of Government invited.

Executive Summary

The opportunity now exists to establish an agri-educational centre in south-eastern Brisbane close to the Gateway motorway connecting the Gold and Sunshine Coasts, twenty minutes from Brisbane CBD and Brisbane airport. The 80Ha of Commonwealth is owned by ACMA and ASA, with the former in the process of off-market divestment to Redland City Council.

This agri-educational hub would showcase Queensland food production heritage and underline the social licence of food production from paddock to plate. It would also be custodian to Redland's food production heritage with possible co-location of Redlands Museum.

Co-location of three 'super-growth' sectors (agribusiness, tourism and education) offers a unique product for south-east Queensland.

Agri-tourism in the Rediands would be more than just farming or food retailing; it would be about connecting city and country without leaving the city and less than ten minutes from Agricultural in the Galexy Motorway to the Gold Coast and two minutes from the route to North Stradbreke Island. It aims to complement Rediand's indigenous culture, fauna and scenic international tourism offering.

Co-locating Redland small-lot farming, farming history and rural community heritage delivers an educational experience that connects food history with food futures.


A commercial kitchen would be available to hire by the hour on a casual or permanent basis. The kitchen be fully equipped to help you start local food businesses create their products, the hourly rate would include, power, gas, water, high quality appliances, cookware, utensils, cleaning chemicals and temporary food storage for a short term. (up to 24 hours free) the commercial kitchens would be used by market stall holders, food manufacturers, caterers and food retail businesses to create, test and manufacture their products. We are happy to expand on any remaining questions regarding the electorate and Parliamentary purpose of Hort Connections and the importance of the Food Hub proposal to the Bowman electorate.

PART B: Dominant purpose of Melbourne leg was Parliamentary.

The electorate-based grounds for attendance at Hort Connections 2019 was outlined in Part A.

Part B summarises two additional meetings that occupied the time prior to Hort Connections. These meetings were not the grounds for the journey, but they were included once the itinerary was settled to maximise value-for-money:

- 1. Afternoon: Melbourne University Graduate School of Education- A/Prof SM and her subsequent referrals to fellow academic experts to discuss a range of topics relevant to schools in my electorate, and as Chair of the Education Standing Committee, relevant to referrals. There was a particular focus on testing and metrics that impact NAPLAN, community support to raise participation rates and how school data is adjusted for socioeducational factors and reported publicly. This work assists me engage and support schools in my electorate where views of standardised testing of students are divisive. It also assists me to explain in detail, trends in ACARA reporting of interest to parents in the electorate.
- 2. Early evening: \$475 findings and particular viewpoints on financial planning reform that were not reflected by the relevant stakeholder groups and were confidential for that reason. There is no financial planner of this size in my electorate. These discussions directly inform the Treasurer's office and provide me with the background required to serve financial planners in my electorate.

These meetings are submitted to demonstrate dominant purpose for the Melbourne journey and to eliminate any other possible purpose for this journey.

If there is any remaining question about the dominant purpose of the Melbourne leg being electorate and Parliamentary related, additional detail on dominant purpose can be provided if required.

PART C:

Attendance at consecutive Hort Connections conferences

Part A and B outline the electorate-based grounds for travel to Melbourne and submits that the 24hour stay in Melbourne was for a dominant electorate and Parliamentary purpose as well as value-for-money. Part C addresses remaining questions of detail.

Bowman is an outer metro, coastal, islands-containing seat, less than an hour from a State capital. The three most significant non-social policy issues are:

- Over-development and loss of agricultural heritage,
- Maximising tourism jobs and the transport infrastructure required.

Based on the above needs and interests of the Bowman electorate, *horticulture and tourism* fall into both categories. This has led to the 2018 appointment of an Economic Development Advisory Board (https://www.redlandcitybulletin.com.au/story/5147858/major-event-specialist-appointed-to-redland-council-board) and as a federal MP, intensive and ongoing engagement in these areas.

Because these two sectors generate some of the highest levels of local interest, attendance at relevant events is imperative and ongoing. Given the direct role the Commonwealth plays in horticulture and tourism, and the electorate projects driven by the Bowman office in these areas, events like *Hort Connections* and *DestinationQ* are attended as frequently as is feasible.

Q1: Names and contacts of sponsor

I did not present at this Conference. It was exclusively a one-to one opportunity for commercial conversations about potential partnering with the Hub proposal. Because only the final day was available due to diary conflicts, the specific electorate objective was satisfied by meeting every possible stakeholder relevant to the Food Hub within a clear timeframe in the final half of the Wednesday Awards running order. No other part of Hort Connections held sufficient electorate value to justify the time required scouring such a large event for these meetings to occur.

The sponsor alluded to previously was a Queensland table sponsor at Hort Connections and AusVeg member who had invested significant time in understanding our proposal and its limitations, examining opportunities across the three days of Hort Connect and identifying relevant entities. Importantly they played no formal role in my attendance nor had any authority to. They played no material role in introductions or negotiations because that was not required. I performed the electorate-related meetings without their assistance, apart from being notified when in the evening meetings could commence. No third party played any role in the authorisation, planning or purpose of this journey, nor managed or arranged the activities at Hort Connections 2019. Taxi records clearly identify the time window of Conference attendance, and the electorate grounds for that attendance is outlined in Part A.

Q2: Attendance arrangements at Hort Connect was the original objective and reason for the Melbourne leg. Conflicting events cut short the Melbourne leg in the days prior to departure, particularly because an important electorate meeting was scheduled for that Tuesday. For this reason, arrangements were in a degree of flux, with the priority to find a way to attend the closing event.

Q3: All introductions and communication was by email. The entire Outlook archive for 2019 is irrecoverable, individual names of representatives from grower groups from two years ago can no longer be recalled.

Q4: The 2018 Food Hub proposal was a substantially different proposition by 2019. The Food Hub was yet to be secured, so a second HC attendance was required.
