SCOPE

 The scope of this assurance review is travel by parliamentarians to Sydney during the period 30 August to 4 September 2019 (the period in scope). This period covers an event held by Channel Nine at their studio in Willoughby NSW. The event had been categorised in the media as a 'corporate fundraiser for the Liberal Party'.

PURPOSE

2. This assurance review aims to assess whether the use of parliamentary business resources by Parliamentarians to travel to Sydney during the period in scope was in accordance with the relevant legislative framework.

BACKGROUND

- 3. Media monitoring indicated that a number of Liberal Party Ministers attended an event held at the Channel Nine Studios in Willoughby NSW on 2 September 2019 (Attachment 1). Media articles indicated the following parliamentarians, who were Ministers at the time, attended the event:
 - Prime Minister Scott Morrison
 - Senator the Hon Simon Birmingham Minister for Finance
 - The Hon Paul Fletcher Minister for Communications, Urban Infrastructure, Cities and the Arts
 - The Hon Dan Tehan Minister for Trade, Tourism and Investment
 - The Hon Stuart Robert Minister for the National Disability Insurance Scheme, Minister for Government Services
 - Senator the Hon Jane Hume Minister for Superannuation, Financial Services and the Digital Economy
 - The Hon Alan Tudge Minister for Education and Youth
- 4. In accordance with IPEA's *Dealing with Allegations of Misuse of Parliamentary Work Expenses* protocol (Attachment 2), an Assurance Review into travel to Sydney during the period in scope of the review commenced on 15 December 2020. For ease of reference in this memorandum, parliamentarians have been referred to by their titles at the time of the Channel Nine event.

LEGISLATIVE FRAMEWORK

- 5. The relevant legislative framework includes:
 - Parliamentary Business Resources Act 2017 (PBR Act)
 - Parliamentary Business Resources Regulations 2017 (the Regulations)
 - Parliamentary Business Resources (Parliamentary Business) Determination 2017 (the Determination).

Obligations

6. The principles based legislative Framework imposes a number of obligations on parliamentarians in relation to their use of public resources. In summary, parliamentarians are personally responsible and accountable for their use of public resources. They must be prepared to publicly justify their use of public resources for conducting their parliamentary business and must act ethically and in good faith in using, and accounting for the use of, those resources. Specifically, a parliamentarian must not claim public resources unless they are claimed for the dominant purpose of conducting their parliamentary business.

Definitions

- 7. 'Parliamentary business' has the meaning given by section 6 of the PBR Act:
 - (1) The *parliamentary business* of a member means any of the following:
 - (a) the *parliamentary duties* of the member, being activities of the member that:
 - (i) relate directly to the member's role as a member; and
 - (ii) are determined for the purposes of paragraph (4)(a);
 - (b) the *electorate duties* of the member, being activities of the member that:
 - (i) support or serve the member's constituents; and
 - (ii) are determined for the purposes of paragraph (4)(b);
 - (c) the *party political duties* of the member, being activities determined for the purposes of paragraph (4)(c);
 - (d) for a member who is an office holder or a Minister of State—the official duties of the member, being activities that:
 - (i) related to the member's role as an office holder or Minister of State; and
 - (ii) are determined for the purposes of paragraph (4)(d).
- 8. Subsection 6(4) of the PBR Act relevantly provides that the Minister must determine activities of a member that are *parliamentary duties* of the member; or *electorate duties* of the member; or *party political duties* of the member; or *official duties* of the member. Details of the activities which are parliamentary business of members are set out in the Determination.
- 9. Subsection 6(2) of the PBR Act further provides in part:

However, an activity is not the *parliamentary business* of a member if:

- (a) the member carries it out for the dominant purpose of either or both of the following:
 (i) providing a personal benefit to the member or another person;
 - (ii) pursuing commercial purposes of the member of another person;...

ANALYSIS

- 10. IPEA obtained an internal report, created from data held by IPEA, for travel to Sydney undertaken by all parliamentarians between 30 August and 4 September 2019.
- 11. Analysis of the data in the internal report identified parliamentarians who travelled to Sydney or in and around Sydney between 30 August and 4 September 2019. Due to the nature of the function which is the subject of review, the data was filtered to remove:
 - Opposition office holders
 - Shadow Ministers
 - Shadow Parliamentary Secretaries
 - all other non-coalition parliamentarians
 - former prime minister not in parliament
 - Widow of former prime minister
- 12. Individual analysis of the data identified travel for 16 parliamentarians who accessed parliamentary business resources during the period in scope. IPEA reviewed travel and travel-related resources used by those parliamentarians, using both IPEA-held and publicly available information. IPEA assessed six (6) parliamentarians as not requiring further investigation as not falling within the scope of the review.

- 13. Five parliamentarians were assessed as requiring further investigation as they had accessed parliamentary business resources in Sydney and were mentioned in media articles about the Channel Nine event:
 - Senator the Hon Simon Birmingham Minister for Finance
 - The Hon Dan Tehan MP Minister for Trade, Tourism and Investment
 - The Hon Stuart Robert MP Minister for Employment, Workforce Skills, Small and Family Business
 - Senator the Hon Jane Hume Minister for Superannuation, Financial Services and the Digital Economy, Minister for Women's Economic Security
 - The Hon Alan Tudge MP Minister for Education and Youth
- 14. Four parliamentarians were assessed as requiring further investigation because they had accessed parliamentary business resources in Sydney at the time of the Channel Nine event:
 - The Hon Michael McCormack MP
 - The Hon Ben Morton MP Special Minister of State, Minister Assisting the Prime Minister and Cabinet, Minister for the Public Service
 - Mr James Stevens MP
 - Mr Llew O'Brien MP Deputy Speaker

Senator the Hon Simon Birmingham

- 15. Senator Birmingham accessed parliamentary business resources to travel from Adelaide to Sydney on 2 September and return to Adelaide on 3 September 2019. On 21 June 2022, IPEA wrote to Senator Birmingham detailing the Commonwealth funded travel provided and requesting information in relation to the dominant purpose of the travel and the nature of parliamentary business during that time (Attachment 3).
- 16. On 27 June 2022, Senator Birmingham confirmed that the dominant purpose of the trip to Sydney was for Official duties, including meetings relevant to the Senator's role as Minister for Trade, Tourism and Investment (Attachment 3).
- 17. On 28 July 2022, IPEA wrote to Senator Birmingham seeking evidence to support the claim that the dominant purpose of the travel to Sydney on 2 and 3 September 2019 was official duties. On 29 July 2022, Senator Birmingham's office provided a copy of the Senator's diary and a link to the transcript of a TV interview conducted on 3 September 2019 as evidence in support of his travel for official duties (Attachment 3).
- 18. Based on the information available, including the responses received from Senator Birmingham, IPEA is satisfied that the dominant purpose of travel to Sydney was parliamentary business. Senator Birmingham's use of parliamentary business resources is not inconsistent with the legislative framework.

The Hon Dan Tehan MP

19. The Hon Dan Tehan MP accessed parliamentary business resources to travel from Canberra to Sydney on 2 September 2019 and from Sydney to Adelaide on 3 September 2019. On 21 June 2022, IPEA wrote to Mr Tehan detailing the Commonwealth-funded travel provided and requesting information in relation to the dominant purpose of the travel and the nature of parliamentary business during that time (Attachment 4).

- 20. As no response had been received, on 28 July 2022, IPEA again wrote to Mr Tehan about his travel to Sydney. Mr Tehan responded on 29 July 2022, confirming that the purpose of travel to Sydney on 2 and 3 September 2019 was for a range of official duties as the Minister for Education (Attachment 4).
- 21. Based on the information available, including the response received from Mr Tehan, IPEA is satisfied that the dominant purpose of travel was parliamentary business. Mr Tehan's use of parliamentary business resources is not inconsistent with the legislative framework

The Hon Stuart Robert MP

- 22. The Hon Stuart Robert MP accessed parliamentary business resources to travel from Coolangatta to Sydney on 2 September, and from Sydney to Canberra on 3 September 2019. On 21 June 2022, IPEA wrote to Mr Robert detailing the Commonwealth-funded travel provided and requesting information in relation to the dominant purpose of the travel and the nature of parliamentary business during that time (Attachment 5).
- 23. On 30 June 2022, Mr Robert responded providing copies of diary entries and details of meetings conducted while in Sydney on 2 September 2019 (Attachment 5).
- 24. Based on the information available, including the response received from Mr Robert, IPEA is satisfied that the dominant purpose of travel was parliamentary business. Mr Robert's use of parliamentary business resources is not inconsistent with the legislative framework.

Senator the Hon Jane Hume

- 25. Senator the Hon Jane Hume accessed parliamentary business resources to travel from Melbourne to Sydney on 2 September, travel within Sydney on 2 September and travel from Sydney to Melbourne on 3 September 2019. On 21 June 2022, IPEA wrote to Senator Hume detailing the Commonwealth-funded travel provided and requesting information in relation to the dominant purpose of the travel and the nature of parliamentary business during that time (Attachment 6).
- 26. Although the data indicated that Senator Hume had accessed COMCAR to travel to and from Willoughby for the Channel Nine event, it has been confirmed that these amounts have been repaid by Senator Hume.
- 27. On 24 June 2022, Senator Hume's staff contacted IPEA and advised that Senator Hume was overseas. The office advised they would access the diary and discuss with Senator Hume to provide any evidence on the purpose of the travel. On 27 June 2022, Senator Hume's office responded advising that the dominant purpose for travel to Sydney was for parliamentary business, noting that Senator Hume had several portfolio related meetings (Attachment 6).
- 28. On 28 July 2022, IPEA wrote to Senator Hume seeking evidence to support the claim that the dominant purpose of the travel to Sydney on 2 and 3 September 2019 was for parliamentary business. As Senator Hume had not provided a response, on 12 August 2022 IPEA resent the letter of 28 July 2022 seeking evidence to support the claim of travel for the purpose of parliamentary business (Attachment 6).

- 29. On 17 August 2022, IPEA provided Senator Hume's office with a copy of the original correspondence sent to Senator Hume on 21 June 2022. On 26 August 2022, IPEA staff had a discussion with staff from Senator Hume's office. Previous discussions with the Acting Director of Audit and Assurance had confirmed that IPEA would accept a letter with evidence or similar from Senator Hume outlining the meetings with portfolio stakeholders. Senator Hume's office undertook to provide this evidence as soon as practicable (Attachment 6).
- 30. On 6 September 2022, Senator Hume confirmed the dominant purpose of travel to Sydney was to conduct meetings with portfolio stakeholders and provided details of those meetings (Attachment 6).
- 31. Based on the information available, including the responses received from Senator Hume, IPEA is satisfied that the dominant purpose of travel was parliamentary business. In relation to the use of COMCAR to and from the Channel Nine event, IPEA is satisfied with the resolution of this aspect by Senator Hume. Senator Hume's use of parliamentary business resources is not inconsistent with the legislative framework.

The Hon Alan Tudge MP

- 32. The Hon Alan Tudge MP accessed parliamentary business resources to travel from Coolangatta to Sydney on 1 September, travel within Sydney and travel from Sydney to Melbourne on 3 September 2019. On 21 June 2022, IPEA wrote to Mr Tudge detailing the Commonwealth-funded travel provided and requesting information in relation to the dominant purpose of the travel to Sydney and the nature of parliamentary business during that time (Attachment 7).
- 33. On 28 June 2022, Mr Tudge confirmed that the dominant purpose of the trip to Sydney was to attend two parliamentary events on 2 September and two parliamentary meetings on 3 September 2019 (Attachment 7).
- 34. Based on the information available, including the response received from Mr Tudge, IPEA is satisfied that the dominant purpose of travel was parliamentary business. Mr Tudge's use of parliamentary business resources is not inconsistent with the legislative framework.

The Hon Michael McCormack MP

- 35. The Hon Michael McCormack MP accessed parliamentary business resources to travel from Wagga Wagga to Sydney on 2 September, travel within Sydney on 2 and 3 September, and travel from Sydney to Canberra on 3 September 2019. On 2 June 2022, IPEA wrote to Mr McCormack detailing the Commonwealth-funded travel provided and requesting information in relation to the dominant purpose of the travel and the nature of parliamentary business during that time (**Attachment 8**). Following a call from Mr McCormack's office, an extension to 08 July 2022 was granted to provide a response.
- On 05 July 2022, Mr McCormack confirmed that the dominant purpose of the travel to Sydney was parliamentary business. Mr McCormack provided a copy of diary entries for 02 September 2022 and details of meetings conducted (Attachment 8).

37. Based on the information available, including the response received from Mr McCormack, IPEA is satisfied that the dominant purpose of travel was parliamentary business. Mr McCormack's use of parliamentary business resources is not inconsistent with the legislative framework.

Hon Ben Morton MP

- 38. The Hon Ben Morton MP accessed parliamentary business resources to travel from Perth to Sydney on 2 September and return to Perth on 3 September 2019. On 21 June 2022, IPEA wrote to Mr Morton detailing the Commonwealth-funded travel provided and requesting information in relation to the dominant purpose of the travel and the nature of parliamentary business during that time (Attachment 9).
- 39. On 30 July 2022, Mr Morton confirmed that the dominant purpose of the travel to Sydney was parliamentary business. Mr Morton stated that he did not attend any event at the Channel Nine Studios while he was in Sydney (Attachment 9).
- 40. As Mr Morton did not attend the Channel Nine function at Willoughby, his travel fell outside the scope of this Assurance review. Mr Morton's use of parliamentary business resources is therefore not inconsistent with the legislative framework.

Mr James Stevens MP

- 41. Mr James Stevens MP accessed parliamentary business resources to travel from Adelaide to Sydney on 1 September 2019. On 21 June 2022, IPEA wrote to Mr Stevens detailing the Commonwealth-funded travel provided and requesting information in relation to the dominant purpose of the travel and the nature of parliamentary business during that time (Attachment 10).
- 42. On 23 June 2022, Mr Stevens confirmed that the dominant purpose of the travel to Sydney was parliamentary business to participate in the Australian Defence Force Parliamentary Program. Mr Stevens provided supporting documentation confirming his accommodation in Sydney on 01 September 2019 and Program attendance from 2 to 6 September 2019 (Attachment 10).
- 43. Based on the information available, including the response received from Mr Stevens, IPEA is satisfied that the dominant purpose of travel was parliamentary business. Mr Stevens' use of parliamentary business resources is not inconsistent with the legislative framework.

Mr Llew O'Brien MP

- 44. Mr Llew O'Brien MP accessed parliamentary business resources to travel from Brisbane to Sydney on 1 September and return to Brisbane on 3 September 2019. On 22 June 2022, IPEA wrote to Mr O'Brien detailing the Commonwealth-funded travel provided and requesting information in relation to the dominant purpose of the travel and the nature of parliamentary business during that time (Attachment 11).
- 45. On 28 June 2022, IPEA provided Mr O'Brien with a copy of the Determination which was referred to in the letter of 21 June 2022. In response, Mr O'Brien confirmed that the dominant purpose of the travel to Sydney was to conduct parliamentary business.

Mr O'Brien provided a copy of his diary as evidence confirming his meetings with portfolio stakeholders and participation in a road safety forum (Attachment 11).

46. Based on the information available, including the response received from Mr O'Brien, IPEA is satisfied that the dominant purpose of travel was parliamentary business. Mr O'Brien's use of parliamentary business resources is not inconsistent with the legislative framework.

CONCLUSION

47. Following a full review of the data and the responses and evidence provided by parliamentarians whose travel to Sydney fell within scope of the review, IPEA is satisfied there was no misuse of parliamentary business resources.



Who attended Channel Nine's Liberal Party fundraiser?

The Liberal Party's \$10,000 per head fundraiser at the Nine Network's Sydney studios on Monday night proceeded without a hitch, despite its public revelation in the early afternoon.

Hosted by Nine chief executive Hugh Marks and his in-house lobbyist Clare Gill, Prime Minister Scott Morrison and a decent chunk of his cabinet (Deputy Senate Leader Simon Birmingham, Communications Minister Paul Fletcher, Government Services Minister Stuart Robert, Education Minister Dan Tehan and Peter Dutton supporter Alan Tudge) broke bread on the set of Nine's breakfast program Today with nearly 40 paying donors. The guests included two former members of federal cabinet: Minerals Council of Australia chairman Helen Coonan (though how she found the time is beyond us) and Servcorp director Mark Vaile. The former Communications Minister brought along the Minerals Council's CEO Tania Constable while the former Deputy Prime Minister attended with his chairman Alf Moufarrige, one of Tony Abbott's long-suffering benefactors. Jamie Briggs never made it past the outer ministry (though in Tudge's Cities portfolio) but the PricewaterhouseCoopers partner was there too, as was Australian Banking Association boss Anna Bligh, Liberal powerbroker Michael Photios, Jones Lang LaSalle CEO Stephen Conry and Meriton billionaire Harry Triguboff, who'll no doubt be pleased that Nine's lot will soon enough be razed and reborn as 460 apartments.

CEO Hugh Marks welcomes Scott Morrison and several government ministers at historic Willoughby TV studios

Aina Eda Meade ent used its historic TV studios in the Sydney suburb of Willoughby to host a store fundraiser for the Liberal party on Monday night.

Hosted by Nine's CEO, Hugh Marks, corporates paid handsomely for the chance to dine with the prime minister, Scott Morrison, and the communications minister, Paul Fletcher, inside Australia's biggest locally owned media company.

Since the merger with Fairfax Media last year, Nine has had control of the Sydney Morning Herald, the Age and the Australian Financial Review, mastheads which have always prided themselves on independent journalism.

That independence was still evident as the venue for the Liberal party fundraiser was revealed by the AFR's gossip columnist Joe Aston.

Nine is emerging as a local rival to News Corp Australia after making a \$113.94m offer to acquire the remaining shares in Macquarie Media, which owns 2GB.

The networking event was organised by the Liberal party's fundraising arm, the Australian Business Network, which asked Nine to host the dinner at Willoughby and carry the cost of the catering.

The TV studio was chosen as a venue because Nine is moving out of the north shore property next year so it has nostalgic value.

Sign up to receive the top stories from Guardian Australia every morning The company has a lease on a \$1.2bn office tower in North Sydney and the journalists from the Nine newspapers will be moving there to join Nine's TV division next year.

All the funds raised - at least \$700,000 - will go into Liberal party coffers.

Nine said the company donated to both the Liberal and Labor parties and executives were attending an Australian Labor party function on Tuesday.

Australian Electoral Commission returns show Nine donated \$27,500 to the Liberal and the Labor party in 2017.

However, Nine sources say they can't remember another time when the media company threw open its doors to raise money for a political party.

"We held the odd boardroom lunch for both leaders but not a party political dinner," a former Nine source said. "It's ludicrous and shocking PR. What does it say about the news brand?"

Other Liberal political guests include the trade minister, Simon Birmingham, the education minister, Dan Tehan, the cities minister, Alan Tudge, and the assistant minister for superannuation, Jane Hume.

The former deputy leader of the Liberal party Peter Costello, who is the chairman of Nine Entertainment, will not attend the dinner.

"The dinner is an opportunity for business leaders to meet and exchange ideas with the Liberal party and we will be doing the same with the ALP tomorrow night at a similar business forum they are holding," a Nine spokeswoman said.

Protocol—Dealing with Allegations of Misuse of Parliamentary Work Expenses

The Independent Parliamentary Expenses Authority (IPEA) was established to provide greater accountability and transparency of the Parliamentary Work Expenses Framework (the Framework). IPEA provides assurance that parliamentarians' work resources and *Members of Parliament (Staff) Act 1984* (MOP(S) Act) employees' travel resources are spent in compliance with the Framework.

IPEA deals with possible misuse of work or travel resources at arm's length from Government. The *Independent Parliamentary Expenses Authority Act 2017* (IPEA Act) provides legislative powers for the auditing and reporting of parliamentarians' work and travel resources and MOP(S) Act travel resources.

When IPEA becomes aware of information that indicates possible non-compliance with the Framework, IPEA may conduct a preliminary assessment. The assessment scrutinises the use of the work or travel resource and determines if a parliamentary business resource has been used.

Possible misuse

In the event of possible misuse, IPEA decides whether to undertake an assurance review or audit of the matter. IPEA does not undertake assurance reviews or audits at the request of parliamentarians or MOP(S) Act employees.

- Under the IPEA Act, IPEA may audit any parliamentarian's work or travel resource or MOP(S) Act travel resource as it considers appropriate.
- IPEA may conduct an assurance review where a preliminary assessment indicates that a Commonwealth resource was used for a parliamentarian's work expense or MOP(S) Act employee's travel expense.
- IPEA may conduct an audit where there are allegations of systemic or substantial misuse of work expenses or where there is an educative benefit.
- An audit may also be a systematic and comprehensive examination of the use by all parliamentarians and/or MOP(S) Act employees of a specific category of work expense.
- The Members of the Authority or the Chief Executive Officer may issue a notice requiring a person to provide information that is relevant to an audit by IPEA, as provided for under Part 5 of the IPEA Act. Criminal penalties apply for failure to comply with a notice, or for providing false or misleading information.
- In the event of an audit, the parliamentarian or MOP(S) Act employee is accorded procedural fairness to provide comment on any findings.

Members of the Authority decide whether a matter is referred to the Australian Federal Police (AFP)

• The Minister responsible for the AFP and the Minister responsible for the Framework are notified of a referral to the AFP.

Publication of audits

• Members of the Authority decide whether, or not, to publish their decision(s).

Good afternoon,

Attached is my diary for the day in question and the copies of the three major entries with a final meeting with the Prime Minister. The dominant purpose was Ministerial. I arrived early into Sydney on the Monday and caught the train to the CPO. I chose not to pre-position the night before so I could spend time with my family as I would be away the whole week. The first meeting was to finalise the six week design sprint by McInseys and KPMG with the Department of Human Services to ultimately create Services Australia as the nation's largest service delivery organisation. The final report, dated 23 August 2019 (10 days earlier) provided a range of options that had to be chosen from. This final meeting decided on a course of action that was ultimately briefed to the Prime Minister that evening.

The next appointment was at the National Disability Insurance Agency (NDIA) Sydney HQ to spend three hours deep diving into the use of functional assessments as the basis for entry into the National Disability Insurance Scheme. The entire executive of the NDIA was present.

The third meeting, at the expressed request of the Prime Minister was to understand the basis of a distributed ledger (block chain) for the expressed use in combating welfare fraud.

The final meeting, of which I had to wait, was to brief the Prime Minister on the outcomes of the Services Australia six week design sprint and my decision on Agency design and build, prior to briefing the Secretary. I also back briefed on why a distributed ledger was not going to be appropriate in welfare public policy and the outcomes of the NDIA discussion as the PM and I were doing a disability round table that Thursday in Adelaide.

I then caught the first flight to Canberra the next day to brief the Secretary on the outcomes and prepare for COAG, GovX and Cyber War Games.




