# **Executive summary**

1. The Independent Parliamentary Expenses Authority (IPEA) conducted an Assurance Review on Mr Craig Kelly's use of parliamentary business resources to travel to a number of interstate locations between February and May 2022.

#### Scope and Purpose

2. The scope of the original Assurance Review was scheduled commercial flights taken by Mr Craig Kelly from Sydney to interstate locations, and travel within these locations, from February 2022 to May 2022. The Assurance Review aimed to determine whether the dominant purpose of the travel undertaken by Mr Kelly was parliamentary business as defined in the legislation.

#### Assurance Review Findings

- 3. Based on the information available to IPEA at the time, the Assurance Review found there was insufficient evidence to conclude the dominant purpose of Mr Kelly's travel to Melbourne on 27 February 2022 and 6 to 7 March 2022 was parliamentary business.
- 4. The Assurance Review was finalised on 15 February 2023 and was published to IPEA's website on 14 July 2023.
- 5. This Addendum addresses additional correspondence received from Mr Kelly following finalisation of the Assurance Review.

#### Conclusion

- 6. As Mr Kelly has now provided the requested supporting documentation, IPEA accepts Mr Kelly's assertion that his travel to Melbourne in February and March 2022 was for the dominant purpose of conducting parliamentary business, and was undertaken within the requirements of the legislative framework.
- 7. The previously raised invoices totalling \$2,530.58 have been cancelled.

### Audit and Assurance function

#### IPEA's statutory audit function

- 9. IPEA audits parliamentarians' work expenses under section 12 of the *Independent Parliamentary Expenses Authority Act 2017* (IPEA Act). IPEA conducts Assurance Reviews to assess the use of parliamentary business resources against the legislative framework to determine whether there has been a misuse.
- 10. Potential outcomes of an Assurance Review include:
  - a. no further action in circumstances where the review has concluded the use of parliamentary business resources was not inconsistent with the legislative framework, or
  - b. administrative remedial action, including penalty where the review has concluded there is evidence the use of parliamentary business resources was not consistent with the legislative framework, or
  - c. an IPEA initiated Ruling or Audit, where there is evidence of systemic or substantial misuse of parliamentary business resources, or
  - d. referral to the Australian Federal Police where compelling prima facie evidence of fraud or other criminal conduct is identified.

# Legislative framework

- 11. The legislation relevant to this Assurance Review is:
  - a. Parliamentary Business Resources Act 2017 (the PBR Act)
  - b. Parliamentary Business Resources Regulations 2017 (the Regulations)
  - c. Parliamentary Business Resources (Parliamentary Business) Determination 2017 (the Determination).

#### **Obligations**

- 12. The principles-based legislative framework imposes a number of obligations on parliamentarians in relation to their use of public resources. In summary, parliamentarians are personally responsible and accountable for their use of public resources. They must be prepared to publicly justify their use of public resources for conducting their parliamentary business, and must act ethically and in good faith in using, and accounting for the use of, those resources. Specifically, a parliamentarian must not claim public resources unless they are claimed for the dominant purpose of conducting their parliamentary business.
- 13. Under subsection 98 (2) of the Regulations, a member must give any claim forms or other compliance information required by the Administrator to:
  - a. the Administrator; or
  - b. a person nominated by the Administrator.

14. Under paragraph 98 (8)(a) of the Regulations, the Commonwealth is not liable to provide public resources prescribed by the Regulations in relation to which a member has failed to provide compliance information as required.

#### **Definitions**

15. 'Parliamentary business' has the meaning given by section 6 of the PBR Act. Activities that fall within the four duty streams of parliamentary business are set out in the Parliamentary Business Determination as 'parliamentary duties', 'electorate duties', 'party political duties', and 'official duties'.

# Assurance Review methodology

#### Background

- 16. IPEA sent 11 letters to Mr Kelly over a period of six months (between 4 May 2022 and 4 November 2022), requesting information in relation to the dominant purpose of his travel using parliamentary resources and the nature of his parliamentary business in a number of interstate locations between February 2022 and May 2022.
- 17. Although Mr Kelly continued to engage with IPEA, he did not provide evidence as requested on a number of occasions to support his claims regarding the parliamentary purposes of his travel to Melbourne on 27 February 2022, and 5 to 6 March 2022 (the relevant period).
- 18. On 3 February 2023, IPEA wrote to Mr Kelly to finalise the matter (**Attachment 1**). IPEA's letter stated that as a consequence of his failure to provide the requested documentation, invoices had been raised for recovery of the business resources accessed for his travel to Melbourne for the relevant period. In accordance with section 38 of the PBR Act, a 25 per cent penalty loading was applied.
- 19. As at 15 February 2023, the invoices had not been paid and the Assurance Review was finalised.

#### Scope of Assurance Review

- 20. The scope of the original Assurance Review was scheduled commercial flights taken by Mr Kelly from Sydney to interstate locations, and travel within these locations, between February 2022 and May 2022. The Assurance Review aimed to determine whether the dominant purpose of the travel undertaken by Mr Kelly for the period was parliamentary business as defined in the legislation.
- 21. The original Assurance Review was finalised on 15 February 2023 and was published to IPEA's website on 14 July 2023.
- 22. This Addendum addresses additional correspondence between Mr Kelly and IPEA following the closure of the original Assurance Review.

#### Method

- 23. Mr Kelly had previously advised IPEA that evidence to support his travel to Melbourne existed in his parliamentary email account, but that he was no longer able to access that account since he was no longer a Member of Parliament. IPEA notes that Mr Kelly was still a Member of Parliament when IPEA's investigations and correspondence on the original Assurance Review commenced, and that Mr Kelly did not provide the evidence requested by IPEA on 11 occasions. IPEA had also informed Mr Kelly that he was able to request access to his records from the Department of Parliamentary Services when he was no longer a sitting parliamentarian, however Mr Kelly did not at any time provide IPEA with records from his previous parliamentary account as supporting evidence for his travel to Melbourne for the relevant period.
- 24. On 29 June 2023, IPEA wrote to Mr Kelly to advise him that the finalised Assurance Review would be published.
- 25. On 8 August 2023, Mr Kelly wrote to IPEA (Attachment 2). In his email, Mr Kelly offered to provide a Statutory Declaration to support his travel to Melbourne for the relevant period. He also provided screenshots of pictures uploaded by the United Australia Party Facebook account, showing Mr Kelly and others stated to be involved with the United Australia Party in Melbourne on a yacht belonging to the leader of the Party, dated 27 February 2022 and 7 March 2022. Mr Kelly said he trusted that the screenshots would clarify the issue and the Statutory Declaration would no longer be necessary.
- 26. On 25 August 2023, IPEA wrote to Mr Kelly (Attachment 3). IPEA clarified that the screenshots were not clear as to the nature of the event involved and that Statutory Declarations are not accepted as evidence where it is expected that material evidence may exist. However, IPEA advised Mr Kelly that in this instance, a Statutory Declaration in combination with the provided screenshots would be accepted as evidence to support the parliamentary nature of his travel to Melbourne for the relevant period. IPEA requested a response from Mr Kelly on these matters by 8 September 2023. IPEA advised Mr Kelly that if no response was received, the debt recovery action for the outstanding invoices would proceed.
- 27. IPEA did not receive a response from Mr Kelly by the due date. Consequently, on 11 September 2023, IPEA's Finance team contacted Mr Kelly to advise that his debt to the Commonwealth was 300 days overdue and provided payment options for the invoices.
- 28. Mr Kelly responded on the same day, indicating that the amount was in dispute and attaching his previous correspondence from 8 August 2023.
- 29. On 12 September 2023, IPEA's Finance team responded to Mr Kelly (**Attachment 4**). They attached IPEA's previous correspondence from 25 August 2023 and advised that the debt was still outstanding and again provided payment options.
- 30. On 20 October 2023, IPEA's Finance team contacted Mr Kelly reminding him that his debt was 330 days overdue and again providing payment options. IPEA advised Mr Kelly that this was his final reminder and if payment was not received, the matter would be referred to a debt collector.
- 31. On 9 November 2023, Mr Kelly wrote to IPEA (Attachment 5) saying he had missed the previous email and providing the requested Statutory Declaration.

# Assessment of work expenses

## Summary of findings

#### **Analysis**

- 32. IPEA considered the additional evidence provided by Mr Kelly against the legislative framework, in particular in the context of:
  - a. Was the dominant purpose of the travel parliamentary business?
  - b. Was the nature of the parliamentary business consistent with the definitions provided in the legislative framework?
- 33. Mr Kelly asserts that the travel to Melbourne for the relevant period was for United Australia Party state conferences and has provided screenshots of himself with others claimed to be associated with the United Australia Party on the relevant dates along with a Statutory Declaration to support his assertions.
- 34. Schedule 3 of the Determination provides:

In respect of the political party to which the member belongs, participating in any of the following in their capacity as an elected Senator or member of the House of Representatives:

- a) a formal meeting of the political party (including a meeting of the party executive, a committee or a subcommittee);
- b) a national, state or territory conference.
- 35. On the basis of Mr Kelly's Statutory Declaration and screenshots, IPEA has accepted that his travel to Melbourne for the relevant period was not inconsistent with Schedule 3 of the Determination.

#### Conclusion

36. As Mr Kelly has now provided the requested supporting documentation, the previously raised invoices totalling \$2,530.58 have been cancelled.

#### Outstanding Assurance Matter - Assurance Review of Travel and Travel-related Expenses

On 4 November 2022, I wrote to you regarding the outstanding Assurance Review of Commonwealth-funded travel and travel-related expenses incurred by you to travel to, from and within Melbourne on 27 February 2022, and 5 to 6 March 2022 (hereafter, 'the relevant period').

In that letter (Attachment A), you were informed that if the requested information in relation to those travel arrangements was not provided to IPEA by 11 November 2022, an invoice would be raised for the relevant expenses. This communication followed repeated requests for that same information in IPEA's letters of 18 May 2022, 31 May 2022, 21 June 2022, 20 July 2022, 17 August 2022, 30 August 2022, 13 September 2022, 29 September 2022 and 12 October 2022.

Under regulation 98 of the *Parliamentary Business Resources Regulations 2017*, you are obliged to provide compliance information in relation to the use of public resources, as required by IPEA. If this information is not supplied, the Commonwealth is not liable for the business resources accessed. As you have not provided evidence in relation to expenses incurred within the relevant period, invoices have been raised for these expenses. A penalty of 25 per cent has also been applied under the provisions of section 38(1) of the Act.

The total amount owed in relation to this matter is \$2,530.58 and has been divided between 3 invoices:





#### **Finalised Assurance Matter**

Thank you for your email of 8 August 2023, in which you provided screenshots of photographs taken during your time in Melbourne on 27 February 2022 and 7 March 2022 from the United Australia Party Facebook page, and queried IPEA's policy on accepting statutory declarations as evidence in Assurance matters.

IPEA does not consider a statutory declaration a valid form of evidence where it is expected that material evidence may exist. You previously indicated to IPEA that evidence to support your travel to Melbourne in February and March 2022 would be available in your parliamentary email account. IPEA first contacted you in relation to this Assurance Review on 4 May 2022, when you were still a Member of Parliament. IPEA requested evidence in relation to your travel to Melbourne in this letter, as well as in letters sent to you on 18 May 2022, 31 May 2022, 7 June 2022, 21 June 2022, 20 July 2022, 17 August 2022, 30 August 2022, 13 September 2022, and 12 October 2022.

In our correspondence of 12 October 2023 (Attachment A), IPEA advised that you are able to contact the Department of Parliamentary Services to request access to relevant records from your parliamentary email account following your departure from parliament.

On 28 October 2022, you responded to IPEA's letter (Attachment B) requesting additional time to access these records. IPEA granted an extension until 11 November 2022 to allow sufficient time for this to occur. IPEA did not receive any further correspondence from you following this letter.

On 3 February 2023, IPEA wrote to you (Attachment C) advising that under regulation 98 of the Parliamentary Business Resources Regulations 2017, you are obliged to provide compliance information in relation to the use of public resources as required by IPEA, and that invoices had been raised for your travel to Melbourne in February and March 2022 as a result of your failure to provide such information to IPEA.

1. 5th/6th March - Melbourne

At this time I was leader of the United Australia Party in the Federal Parliament, a party which had more registered members than any other political party in Australia. As I such I was required to travel frequently to the various states for state conferences with members.

This trip to Melbourne was a state conference of selected south Australian members, who flew in to Melbourne for the Conference.

This STH Australian state conference was held in private and was not advertised or promoted in the media. I would happily provide a statutory declaration to attest to these facts, and I'm sure that other attendees would as well.

Outstanding Assurance Matter - Assurance Review of Travel and Travel-related Expenses

On 4 November 2022, I wrote to you regarding the outstanding Assurance Review of Commonwealth-funded travel and travel-related expenses incurred by you to travel to, from and within Melbourne on 27 February 2022, and 5 to 6 March 2022 (hereafter, 'the relevant period').

In that letter (Attachment A), you were informed that if the requested information in relation to those travel arrangements was not provided to IPEA by 11 November 2022, an invoice would be raised for the relevant expenses. This communication followed repeated requests for that same information in IPEA's letters of 18 May 2022, 31 May 2022, 21 June 2022, 20 July 2022, 17 August 2022, 30 August 2022, 13 September 2022, 29 September 2022 and 12 October 2022.

Further to the most recent correspondence.

I note at point 29 of the attached letter that it states that IPEA accepts statutory declarations where it believes that all other avenues for providing material have been exhausted.

In my previous correspondence in relation to the travel in question, Sydney/Melbourne on 27th Feb 2022 and separately on 5th & 6th March 2022, I advised that no media was invited to these events and that I no longer had access to my parliamentary email system and diary since being defeated at the last election. Therefore having exhausted avenues to provide material, I offered to provide a Statutory Declaration.

Thank you for your email of 8 August 2023, in which you provided screenshots of photographs taken during your time in Melbourne on 27 February 2022 and 7 March 2022 from the United Australia Party Facebook page, and queried IPEA's policy on accepting statutory declarations as evidence in Assurance matters.

IPEA does not consider a statutory declaration a valid form of evidence where it is expected that material evidence may exist. You previously indicated to IPEA that evidence to support your travel to Melbourne in February and March 2022 would be available in your parliamentary email account. IPEA first contacted you in relation to this Assurance Review on 4 May 2022, when you were still a Member of Parliament. IPEA requested evidence in relation to your travel to Melbourne in this letter, as well as in letters sent to you on 18 May 2022, 31 May 2022, 7 June 2022, 21 June 2022, 20 July 2022, 17 August 2022, 30 August 2022, 13 September 2022, and 12 October 2022.

In our correspondence of 12 October 2023 (Attachment A), IPEA advised that you are able to contact the Department of Parliamentary Services to request access to relevant records from your parliamentary email account following your departure from parliament.

On 28 October 2022, you responded to IPEA's letter (Attachment B) requesting additional time to access these records. IPEA granted an extension until 11 November 2022 to allow sufficient time for this to occur. IPEA did not receive any further correspondence from you following this letter.

On 3 February 2023, IPEA wrote to you (Attachment C) advising that under regulation 98 of the Parliamentary Business Resources Regulations 2017, you are obliged to provide compliance information in relation to the use of public resources as required by IPEA, and that invoices had been raised for your travel to Melbourne in February and March 2022 as a result of your failure to provide such information to IPEA.





Further to the most recent correspondence.

I note at point 29 of the attached letter that it states that IPEA accepts statutory declarations where it believes that all other avenues for providing material have been exhausted.

In my previous correspondence in relation to the travel in question, Sydney/Melbourne on 27th Feb 2022 and separately on 5th & 6th March 2022, I advised that no media was invited to these events and that I no longer had access to my parliamentary email system and diary since being defeated at the last election. Therefore having exhausted avenues to provide material, I offered to provide a Statutory Declaration.

However, at the time I was advised that Statutory Declarations were not an acceptable form of evidence. It was therefore surprising to read in the recent correspondence that contrary to previous advice, that IPEA do accept Statutory declarations in certain circumstances.

Therefore, I again offer to provide a Statutory Declaration in relation to the travel in question.

In addition, I have since come across social media posts on Facebook from the United Australia Party in relation to the travel in dispute.

I was unable to access these posts previously as I am banned from life from the Facebook platform. As such I trust that these posts will clarify the issue and a Statutory Declaration will not be necessary.
